

- Microsoft filed 73 patents related to Artificial Intelligence (AI) in the last 5 years: eyecare, disability research, Cloud Initiatives
- Amazon has acquired wholesale pharmacy licenses in 12 states, with at least one other pending, signaling a possible entry into the pharmacy business by the online retail giant
- Ochsner HS AI to predict Advanced Patient Outcomes using EPIC and Azure
- Microsoft Cyber Security after ransomware attack "Wanna Cry" May 2017
- Genomics: Microsoft Telehealth expand border coverage to respond to physician shortages in underserved populations
- VBP and Social Disparities
- Interoperability betw. Health Systems
- Google AI Assistant
- Alphabet (Google plus) making bets in life sciences
- Google making significant investments in health, wellness, and life sciences (i.e. + Ganar Interferon proteins used for BS detection= 85% accurate)

- Artificial Intelligence: CAGR of 42% to reach \$6.6 billion in 2021
- Immunotherapies: Checkpoint inhibitors growing at 139% CAGR
- Liquid Biopsy: Potential to monitor tumors non-invasively
- CRISPR/Cas9 (RT): Disrupting the way R&D is conducted and products are developed
- 3D Printing: Game changer for organ or tissue repair




